Enhancing Communication for HIV Outcomes (ECHO Study),

Site PI: a substudy of HIVRN funded by AHRQ and HRSA through Johns Hopkins. Patients and clinicians from each of 4 participating clinics were enrolled and completed pre- and post-questionnaires, randomized clinicians underwent brief motivational interviewing training, and clinic visits were audiotaped.
